




Timescales and application process



- Year 12 start their research on courses and universities, attend large UCAS exhibitions and smaller HE/Careers Fairs, attend advice talks or use UCAS advice
- End of year 12/summer/early in year 13 attend open days, narrow down their choices
- Year 13 September to January they apply
- Year 13 October to June they receive offers and make final decisions
- Summer after year 13 results, final preparation before starting uni
- Late Summer/early Autumn begin their course



Student Finance







What students have to pay



The 2 main expenses they will have whilst at university are:

- Tuition fees £9,535 per year for UK and EU students starting full-time undergraduate courses in September 2025
- Living costs accommodation or commuting, food, travel, study materials e.g., books, and other course costs, leisure, social etc. Living costs will vary according to the lifestyle choices they make.





Financial support

For students from Jersey, support is available to help with the cost of course fees and living costs. Financial assistance is means-tested and takes the form of a grant, which does not need to be repaid unless they withdraw from their course.





Financial support



The government of Jersey provides financial help for Jersey students who want to continue studying.

The amount they can receive is means-tested and has two elements:

- 1. Tuition fees: Up to £9,535 per year.
- 2. Maintenance grant: Up to £9,138 for a standard academic year. This helps to pay some of the living expenses towards accommodation, food, utility bills and books.

Financial support: How to apply



You must apply for student finance well before your course starts to make sure you receive your grant for the beginning of term.

Apply using the online form below. You must complete an application for each child. Once we receive and review your application, we'll send you other forms you may need to complete, including Income Statement forms (HE2).

Deadlines for applications

You can apply between 1 January to 31 December for courses starting on 1 September of the same year to 31 August the following year.

You Income Statements (HE2) must be submitted by 31 March for the academic year you're studying in. We will not accept late applications.


Note: parents/carers will need to submit a new income statement form for each academic year. For continuing students this will be automatically sent out by Student Finance at the beginning of calendar each year.







Steven Spielberg, film director Went to California State University Gained his degree in film and electronic arts age 55




Lenny Henry, actor, comedian, presenter and writer Gained his English Literature degree from the Open University in 2007

Get a part-time job or undertake volunteering.




Keeping their options open



Am I eligible for funding?



Eligibility

Residency Criteria

- Resident in the Island for 5 years prior to start date of course.
- Resident for 12 months if the student or parent hold "Entitled" status prior to start date of course.
- A student can have a maximum of twelve months out of the Island during a 5 year period. (If they are taking a gap year or have had a few trips away contact the department to discuss dates etc.)

Eligible courses

- Foundation degree
- BA/BSc etc
- Certain postgraduate courses
- Courses outside the UK must be of the same level as above
- We do not fund foundation years, apart from an Arts related foundation year.

How much will it cost and how much funding will I be entitled to?

Entitlement



The Student Finance grant is means tested and is calculated according to gross annual income and net assets.

- If you are under the age of 25, you are a dependent student, and the grant is assessed on you parent's gross income. (If parent's joint income is over £210,400 or they have assets of over £500,000, there is no entitlement).
- The Standard UK tuition fees are £9,535 per year, plus there are your living costs.
- We will pay a maximum of £9,535 towards tuition fees whether you are studying in the UK or abroad.
- You are assessed every year that you are at university.



When and How to Apply

- Apply online via: Student Finance guidance and application (gov.je)
- Once you have made applications to universities you can apply from the January through to 31st December in the year that you are starting your course







When Will I Get My Grant and How is it Paid?



- There are two elements to the grant, the tuition fees and the maintenance grant (living expenses)
- For a UK or on Island course, we pay the tuition fees directly to the
 university. If we are not covering the all the fees, the university will invoice
 us for our contribution and invoice you/parents directly for the remainder.
 We pay the universities termly, Autumn, Spring and Summer.
- If the student is studying abroad, parents must pay fees directly to the university and we will reimburse when proof of payment is provided.
- We pay the maintenance directly into the student's bank account. The maintenance is paid termly, Autumn, Spring and Summer.
- The Autumn grant is paid the 2nd Monday in September, the Spring grant is paid beginning of January, and the Summer grant is paid beginning of April

What else can Student Finance assist with?

- DSA (Disabled Student Allowance):
- Equipment /software (If the income is below £94,680)
 - 1:1 Support (not means tested on income)
- Interview expenses (income below £52,600)
- Field trip allowances
- Vacation study allowances



The Nuts and Bolts Applying **Student Finance**

- 1. Apply to the university/universities of your choice
- 2. Submit your HE1 application to Student Finance in the January of the year you are going to start your course. Remember to tick the DSA box if you wish to apply for DSA.
- 3. When we process your application, we will send you an approval letter by email, which will be sent to yourself and both of your parents.
- 4. The email will include a link for an on line HE2 Income Statement form, which needs to be completed by your parents' providing details of their income for yearend 31st December of the year prior to the start date of the course. (If you are starting your course in academic year 2025/26, we will require income details for 2025.
- 5. There will be a BACS Details form attached to the email for the student to complete and return to Student Finance providing their bank details.
- 6. At the same time the Approval email is sent, a second email is sent to the student with a link for the online HE7 form and a link to apply for Student Credits.

- 1. The HE7 form cannot be completed until you have received an unconditional offer letter. You will also need to send a copy of your unconditional offer to Student Finance by either uploading to the SF Portal Student Finance Document Upload Portal Information one.gov.je or you can email a copy to studentfinance@gov.je
- 2. You can also apply for Student Credits once you have turned 18. The link to apply will be included in the email sent to you with the link for the HE7 form.
- 3. Once we have received all documents mentioned above, we will complete your application and send you a notification letter by email. This email will be sent to yourself and to both parents.
- 4. The Notification Letter confirms the amount of your grant award.
- 5. When you start university, you must show the notification letter to the university, so that they know who to invoice for the tuition fees.
- 6. Once we receive an invoice from the university, we are able to pay the Autumn instalment of the tuition fees. The Spring and Summer terms will then be paid automatically by SF.

Things to Think About?

What happens if I don't complete my degree?

There is a liability to repay part of the grant that you have received, usually the last terms tuition fees that were paid, unless it is due to medical reasons or other extenuating circumstances. If so, we will require medical evidence etc.

- You may be able to apply for Trusts and Bursaries. If you are eligible for a bursary, it will not affect
 your funding from SF.
- Who can I talk to if I have any problems/concerns whilst at university?
 - Student Services/Support at your university
 - Speak to your parents
 - Call Student Finance or email us
 - Student Finance have their own Face Book page where you can access information and updates.



UNIVERSITY APPLICATION PROCESS

COMPLETE APPLICATION

- Complete 'Admin ' sections
- This includes their universities- ones they want to go to.
- They can send the application off with 3 in and add 2 later
- Have one aspirational.
- 2 or 3 at their predicted grades. Subject teachers use of data and professional judgement.
- Insurance below predicted grades- make sure you want to go to your Insurance

EXAMPLE

I am predicted 3 Bs

- Aspirational choice ABB
- 3 choices at BBB
- Insurance BBC or BCC

PERSONAL STATEMENT

- A- Activity- what did you do?
- B- Benefit- What did you learn?
- C Course- how does your activity link to your chosen course?

- Unis want to know why they are fascinated by your subject-
- Academic reading/ MOOCs/ Relevant work experience/ TED Talks/ Blogs/ Websites/ YouTube

PROCESS TO SEND OFF APPLICATION

- Once their Personal Statement is complete and they have completed all the 'admin' part, they make an appointment to see their Mentor.
- If they are finding your Personal Statement difficult speak to your mentor.

 Unifrog and UCAS personal statement builders
- It will probably go though 3 or 4 drafts
- Their mentor will complete your reference and then contact a 'Final Checker'

FINAL CHECKER

- The final checkers are Miss Jackson, Miss Devine, Miss de Jesus-Oeillet, Mr. Campbell, Mrs Hale and Mr. Price
- They are the only ones who can send the application to UCAS
- They/ we will check GCSE certificates have been checked
- Application/ Personal Statement and Reference are error free
- You pay £28. 50 Card payments only
- And then SEND!!!

2026 DEADLINE

The Equal Considerations Deadline next year is Wednesday 14th January, 1800 Statistics to consider:

- 149 applications sent
- 53 sent in the 3 months before Christmas break
- 84 sent in the 8 working days before the deadline
- This has an impact on the support provided to students and the deadline is earlier this year
